## Notes on particular boxes

- No. 2 In these boxes, please always indicate natural persons. 'Declarant' means the person making the customs declaration in his/her own name or the person in whose name a customs declaration is made (Article 4 no. 18 Customs Code).
   With regard to a representation it has to be considered that the customs declaration imposes particular obligations on a beneficiary. Therefore, the declaration may be made only by that person or on his/her behalf (Article 64 (2) letter a) in conjunction with Article 5 Customs Code).
- No. 6 The kind of individual packages has to be given with the customary goods description. Generic names such as spirits and/or diplomatic cargo are not permitted. Moreover, indicate the respective units for the goods (e.g. liters for bottles, pieces for cigarettes).
- No. 10 That is, the signature of an authorized signatory for customs and excise purposes who does not necessarily have to be the head of the representation.
